## THESE TERMS AND CONDITIONS ARE AN INTEGRAL PART OF THE AGREEMENT

### 1. Event - Venue, dates and times

The event takes place **from 8 to 9 October 2016 in Arta Terme (Udine - Italy)**. The arrangement of the exhibition space must be done **by Saturday at 10am**. The exhibitions spaces are located on open space.

### 2. Application

Application for exhibition space must be made on the form provided. With signature of the application, the exhibitor recognizes the General Terms and Conditions. **Exhibitors must provide to attach to the application a copy of his license and all permits required by law the exercise of the activity.**

### 3. Admission

The organizer reserves the right to grant or refuse any application without giving reasons. Receipt of the application will be confirmed in writing by the organizer. The transfer of all or parts of the exhibition space, even free of charge, is strictly prohibited.

### 4. Payment

The deposit (50% of the whole amount due) must be enclosed to the application form. Applications that are not accompanied by payment of the deposit shall not be considered valid. The balance (remaining 50%) must be settled with bank transfer by September, 30<sup>th</sup>. **The exhibition area will be occupied only after execution of the balance.** Full payment in accordance with the amount on the approval is a condition for the acquisition of exhibition space. In the event that the rental fee is not paid, the organizer is entitled to allocate the stand to other exhibitors and the exhibitor has no right to claim damages.

### 5. Arrangement of the exhibition space

The organizer shall be entitled to change size, form and location of the assigned exhibition space, if necessary. If such need arises, the organizer shall notify the exhibitor. The exhibitor is entitled with the arrangement of the exhibition space. The maximum depth of the stands is 5 metres (van included). The organizer supplies the CEE electrical connection; the standard supply is 1 KW. In case of higher supply requirement, he must ask it to the organizer. Extensions cords and plugs are not supplied. The exhibitor has to provide extension cords (at least 30m). Any visual or acoustic disturbance of adjacent areas must be avoided. **The stand personnel should perform their own AGIAP any costs.**

### 6. Stand construction and dismantling

Stand construction: Friday from 9 am; the arrangement of the exhibition space must be done by Saturday at 10 am.

Stand dismantling: Sunday after 19 pm.

### 7. Force Majeure

In the case that the organizer has to shorten or cancel an event due to force majeure, the exhibitor shall not be entitled to claim damages or return of amounts already paid. In case of rescheduling the event, this agreements keeps its validity on the new scheduled date.

### 8. Withdrawal

Application Form is irrevocable and binding and any cancellation thereof must be in writing not later than 8 weeks prior to the beginning of the show. 25% of the agreed value of the exhibition space will be invoiced nevertheless. For any cancellation after this term or if an exhibitor has not occupied space allocated by 10 am on saturday, the full amount for the ordered exhibition space will be invoiced and the deposit paid will not be refunded.

### 9. Liability and insurance

The exhibitor is liable, rather than the organizer, for all damages caused by the exhibitor, those employed by the exhibitor, those assigned by the exhibitor, or the exhibition equipment and installations to any person or object. The exhibitor is liable for all damages to the stand configuration rented from the organizer. The organizer is not responsible for the exhibition objects of the exhibitors.

### 10. Fire, Safety and Security Regulations

The exhibitor must follow unconditionally the Fire, Safety and Security Regulations

### 11. Place of jurisdiction

The place of jurisdiction shall be the city of Udine/Italia.
